Election Process - FIH Statutes

Article 7.1(a)(i) FIH Statutes

The President, who shall be elected by Congress in accordance with Article 7.2 of the Statutes:

Article 7.1(a)(ii) FIH Statutes

Eight (8) ordinary members, each of whom shall be elected by *Congress* in accordance with Article 7.2 of these *Statutes*, PROVIDED ALWAYS THAT four (4) of the members must be female and four (4) must be male;
