**Subject: Notification of Hearing and Decision** 

Re: Mexico Player no. 26, RAMIREZ Oscar, 2 yellow cards

This is to inform you that a disciplinary hearing has been scheduled to address the 2 yellow cards that occurred during the Junior Pan American Championship, Men in Match #11 and Match #13.

**Details of the Incident:** Two yellow cards were issued during the following matches:

- Match #11 USA vs Mexico a 5-minute yellow card was obtained for a physical play violation
- Match #13 Brazil vs Mexico a yellow was obtained for a 5-metre violation

**Hearing Details:** You are required to attend this hearing to discuss the incident and present any evidence or witnesses you may have and determine appropriate sanctions. Please be aware that failure to attend this hearing may result in a decision being made in your absence.

#### Level of the Offenses

Code of Conduct Level 1

Article 2.2 (I) where the facts of the alleged incident are not adequately or clearly covered by any of the above offences, conduct that either is contrary to the spirit of the game or brings the game into disrepute and (f) Inappropriate and/or deliberate physical contact between players in the course of play.

As Oscar RAMIREZ did not speak English, he requested interpretation. Julian LARES, Assistant coach, Mexico served as the interpreter.

#### TD's Decision

The two yellow cards were reviewed, which were a 5-minute yellow card for a physical play violation and a 5-meter violation. Oscar RAMIREZ did acknowledge he understood the rule of the 5 metres and admitted that he was wrong on that occasion. He also accepted the breach of the physical play and explained that it was not intentional.

# The disciplinary history of the team member: none

Oscar RAMIREZ accepts the breaches of the Code of Conduct. His attitude during the hearing was regretful.

**Any penalty already incurred**: This player served a total of 10 minutes suspension.

An Official reprimand with report submitted to FIH and PAHF.

Any future yellow cards in this tournament may result in suspension.
